1. Welcome

3. Alabaster Township Recreation Plan

- Jennifer Stewart (Spicer Group) presented the plan and the final draft. Public input was first obtained by an online survey and now during the public hearing meeting at present.

- Jim Kirchner (1657 Douglas Drive) provided his comments on the plan. Kirchner stated the title of the Bike Path should be "Alabaster Township Bike Path & Arboretum" instead of "Alabaster Township Bike Path Arboretum". Discussion was held on this point.
- Kirchner also stated there are many grammatical errors in the Appendix where survey comments are listed. Tubbs stated this has been discussed before and the feeling of the Board is that we cannot alter the comments since it could change the intent and nature of the comment.
- Wentworth asked for any additional public comment. Public comment portion of the meeting was closed at 5:27pm.

- *Czaika made motion, seconded by Paskiewicz, to approve the Recreation Plan as modified. Roll Call: Ayes-Wentworth, Paskiewicz, Czaika, Tubbs; Naves-none. The motion passed.*
- *Wentworth made a motion, seconded by Czaika, to adopt Resolution 2021-01, Alabaster Township Recreation Plan. Roll Call: Ayes-Wentworth, Paskiewicz, Czaika, Tubbs; Naves-none. The motion passed.*
